C. Discussion/Approval: Welch Road Culverts – John “Snoop” Evans, Glacier County Road Supervisor

John “Snoop” Evans, Glacier County Road Supervisor states that the road department will need to redo the Welch Road culverts in the area of the bridge per the State’s request. The cost of the culverts is over the \$5,000.00 threshold and requires an approval from the commissioners to purchase. The total cost will be \$27,730 from Oilfield Lumber who is a local business. We did get another cost from Glacier Cast Concrete in the amount of \$36,366.00. It’s decided that they will go with Oilfield Lumber in the amount of \$27,730.00.

Commissioner Billedeaux motions to approve the culvert purchase from Oilfield Lumber in the amount of \$27,730.00; Commissioner Overcast seconds the motion; motion carried.

D. Discussion/Approval: Water Truck Repairs - John “Snoop” Evans, Glacier County Road Supervisor

Jimmy Racine, Glacier County Road Dept explains that this is our second water truck in need of repair. It has a leak in the tank in which they lose around a 1/3 of the tank of water by the time they get to the job site. The cost to repair this leak is going to be under \$5,000.00. We just wanted to update the commissioners on this repair through Pack Construction LLC who did the previous repair.
