**D. Discussion/Approval: Glacier County & Logan Health Emergency Medical Services – EMS Facilities and Ambulance Lease Agreement – Chancy Kittson, Glacier County CFO/Glacier County Commissioners/Logan Health**

Chancy Kittson, Glacier County CFO presents the new Glacier County & Logan Health Emergency Medical Services facility and ambulance lease agreement for approval. He explains that the first lease agreement was in October 2020 and this agreement is essentially the same except now they have added in the Babb Ambulance Service under the agreement. In the past Glacier County handled the expenses and insurance for the Babb EMS Building/Operation, but it will be handled by Logan Health Emergency Medical Services going forward. The effective date of the agreement is as of April 1, 2024 and will conclude on April 1, 2027. The agreement has been approved by the Glacier County Attorney.
